By GB law, a sex offender must live more than 1000' from a designated school, but most offenders are in violation of that statute. We'd rather know where they are living.

Officer Van Handel is trying to get the speed board back on S. Monroe, to slow down traffic near Aldo Leopold. Some concern also about a few people blocking off driveways by people picking up kids at Aldo Leopold. Board members repeated the concerns about the speed issues on S. Monroe. We were encouraged to call Lt. Ackermann, to request the speed board. An Astor Outlook newsletter article would be helpful.
